



Welcome to the “Haus der Eigenarbeit“ (open workshops)

It is our wish that all visitors enjoy their stay at the “Haus der Eigenarbeit“. Therefore, we kindly ask you to adhere to the General Terms and Conditions of the “Haus der Eigenarbeit“.

General Terms and Conditions

Every person who enters the premises of the „Haus der Eigenarbeit“ and/or stays at the „Haus der Eigenarbeit“ in order to make use of any of its facilities and equipment or offers, acknowledges and accepts the user regulations.

User Regulations

1. Before starting to use the machines and tools, all users are obliged to first seek guidance from the staff supervising the workspace (“Werkstattbetreuung”) or the technical experts (“Fachberatung”) on the appropriate and safe usage of the machines and tools. Furthermore, they are obliged to adhere to the advice from our personnel with respect to operating the machines and safety, to adhere to the written instructions on the machines and to act accordingly.
2. The use of all facilities of the “Haus der Eigenarbeit”, e.g. the use of the rooms, the machines and the tools is at the user's own risk.
3. Instructions of the Association, its legal representatives or its staff (technical experts, supervising staff) are to be complied with.
4. All users have to make sure that their actions do not impair proper and safe operation at the “Haus der Eigenarbeit” and that other persons are not put in danger or molested.
5. All users are obliged to make appropriate use of any of the facilities and the equipment, in particular the machines and tools, and to use them for the intended purpose only. All users are liable for any damage caused through their own fault. The staff has to be notified immediately on any damage.
6. The use of the “Haus der Eigenarbeit” is intended for private needs only. The staff has to be notified of the user's own accord if the facilities and equipment are used for commercial purposes. Use for commercial purposes is subject to other prices and taxes.
7. All users consent to the publication of photographs showing themselves or their projects in the framework of public relations work carried out by the “Haus der Eigenarbeit” as long as no statement to the contrary has been made.

Liability

1. The “Verein zur Förderung von Eigenarbeit e.V.” (Association for promoting Do-it-yourself projects) is not liable for personal injuries or property damages. In case of gross negligence or wilful damage or injury caused by the Association or one of its legal representatives or a member of staff (technical experts, supervising staff or the like), the Association is liable within the framework of existing insurance contracts (third party liability and property insurance).
2. In case of breach of contract due to simple negligence the Association as responsible body is only liable if a duty is concerned that is essential for carrying out the contract.
3. Any alleged claims towards the Association must be made without delay.
